**ASHA MEMBERSHIP STATEMENT**—Beginning with the 2019 competition year, owners, riders, drivers, handlers and trainers of American Saddlebred horses showing at open shows recorded with ASHA must be current ASHA competing members for points counted for KSF/WCHS Qualifying, National Pleasure and ASHA High Point Awards. Effective February 4, 2019, any individual that appears on the Safe Sport or USEF banned or suspended lists cannot be in attendance, compete or participate in such competition in any manner, including as a trainer, coach, owner or exhibitor of horses or ponies.
